



fabricated organized crime reports to attorney Jay Milano that incriminated all of us which set off the cover up stage of this conspiracy which we all participated in. I had no choice in the matter. I have tapes of Det. Brady and others of the Organized Crime Unit threatening me after they all started to get caught.

11. This conspiracy against Jeffrey Keith began in 1995 and continues today, because they are still hunting Chris Lawrence. Lawrence caught them falsifying documents in a case involving a senior citizen against Keith among other things. I went to Carmen Marino's office and the F.B.I. and tried to explain and ask for help, but Marino and others were involved so it didn't do any good.

I hope this does some good. I have other information, however, considering others have already explained the story I can only add my portion of it. I fabricated reports and testimony under duress and did not do so of my own free will. It was clear from the beginning that police had shadowed Keith for a long period of time and got involved in his personal life and then began fabricated evidence against him. Det. Brady told me about their efforts.

The following is the statement of Glenn C. Dameron W/M DOB 08-09-56, SSN 270-58-8307, Home Address: 25151 Brookpark Rd. #811, North Olmsted, Ohio 44070, Home Phone: 779-1752, Employment: Consolidated Management Inc. Electrician, Chagrin Blvd. Beachwood, Ohio

I first met Jeffery Keith on November 17, 1995 about 6 o'clock p.m. in County Jail 7D pod. He and I walked a lot together and we had a casual acquaintance James McElroy a private detective. My dealings with James McElroy was strictly over a dog I had given him. As it turns out through conversation with Jeffery Keith this same private investigator was one he hired to get a phone number of a woman (unknown name). We had conversations about James McElroy and Jeffery Keith had put together a plan involving McElroy, Kovacic and O'Malley. Jeffery Keith now wants me to go see his lawyer Jay Milano to give deposition of false information pertaining to the above police officers and private detective. After I go to the lawyer and give this false deposition, He wants me to be in contact with someone who intends to burn a house down belonging to that officer Kovacic. My part in this is to make an entrance into the house and to close the entrance up after he leaves. He wants to make sure that the investigators do not discover that the house had been entered. He wants the house to look perfect. He is very smart and calculating. He stops and thinks before he speaks. I am suppose to contact him Thursday December 21, 1995 at 2:30 p.m.


- Q. How many days after you met Jeffery Keith did he ask you to give the deposition and help with the arson?
- A. That was put together over a two week period.
- Q. During your conversations with Jeffery Keith did he ever say that he was guilty of the crimes that he was accused of?
- A. He just said that it had a lot to do with drugs. He said that he treated her as she treated him.
- Q. Do you believe Jay-Milano is aware that your deposition is going to be false?
- A. I don't know. I do know that he said he just paid his attorneys twenty-one thousand dollars.
- Q. Why did Keith want you to give this false deposition to his attorney?
- A. Because Officer Kovacic was the main testimony that hurt Keith. He said that this would cloud Kovacic's testimony for his appeal. That also involves the testimony of James McElroy. They both testified against him.



- Q. Did Keith tell you what to say in you deposition?
- A. Yes, He told me to say that James McElroy, that I did some things for James McElroy in 1988 and 1989. That I committed some break-ins for McElroy who was working for Kovacic and O'Malley. This would taint their character. He said that the statute of limitations was past and I would not have to worry about it.
- Q. How frequently did you and Keith talk about this?
- A. Five or six times a week during the two week period.
- Q. Was anyone else in the pod at County Jail aware of this matter?
- A. Not to my knowledge. He does always talk to a guy named James Lang.
- Q. Did Keith ever give you the name of the person that is going to commit the arson?
- A. No, he said that was later on down the line.
- Q. Did you discuss payment for the arson with Keith?
- A. Jeffery Keith is the one that said to me that it would be worth ten thousand dollars to me. He also said that he would pay me five thousand dollars up front and five thousand dollars after the arson. He said that the person who was going to commit the arson would pay me.
- Q. Did Keith say why he wanted Kovacic's house burned?
- A. Yes, he said it was personal. He hates someone to get the upper hand on him. Kovacics' testimony was the one that damaged him the most.
- Q. What caused you to contact the Police Department?
- A. Because he told me on Thursday December 14, 1995 that he had called the FBI and left them my name and told them that I needed to talk to them about wrong doings between a police officer and the private investigators. This would set up my deposition with Milano.
- Q. Do you know of anyone in County Jail that may be giving Keith police information?
- A. No, but he knew about my criminal record, how long I have been in jail and what I was in for, breaking and entering.

- Q. Have you talked to Keith today?
- A. Yes, before I left 7D pod on bond. We set up a time to give the deposition to Jay Milano and the time to call him (Keith) on Thursday. He wrote a note he gave me Jay Milano's phone number his (Keith's) address and telephone number. I am to call his house and his daughter Kristine will relay the message.
- Q. Do you believe that Jeffery attorney know about the arson plot?
- A. Not to my knowledge, he has never said anything bad about his attorneys. He contacted Jay Milano to come and see me in jail. Jay Milano felt that is was better if I came to his office.
- Q. Did Keith tell you the exact time that he wanted this done?
- A. As soon as possible after I give the deposition to his attorney.
- Q. Did he discuss getting you any type of false identification if needed?
- A. Yes, he did if I needed it he had a friend, a woman, who works at the license bureau at East 30th and Euclid she could get a false drivers license for \$90.00. If things got too hot, I could go to his house on Peach Street in Erie, PA. This house is on a cul-de-sac. No one is living in it. He daughter went up there last week to check on it.
- Q. Have you talked to any other persons about this?
- A. Kovacic in Homicide. I got the wrong Kovacic through the operator. I wanted the Kovacic in Arson.
- Q. Are you willing to work with the Police Department?
- A. Yes, I took it upon myself after he called the FBI to contact the Police Department.
- Q. Has anyone in the Police Department promised you anything in exchange for your help and testimony regarding this matter?
- A. No
